HIGHWAY SUPERINTENDENT REPORT: 04/18/2017 \* Larry White In the last month we have had trucks out only 4 times on plowing or sanding.

We have worked with National Grid on tree removal for 4 days. We took down problem trees on the Dutton, Hewlett, Pestle Street, West and Russell Pyrites roads.

The County also worked with us on 3 trees on the Dutton Road.

We helped the County with rock removal in Gouverneur with the army trucks.

We have completed sand clean up in town and DeGrasse as well as several roads on the south side.

We worked on filling our wood sheds for next fall as time allows.

We have patched all roads for the first time.

We are now grading gravel roads as the weather allows.

We have replaced 1 pipe crossing on the Tooley Pond road.

This has been a very productive month and I thank the men for their efforts.

Larry handed in \$50 cash to Tess to hold till board meeting from the sale of the Dodge Truck that was put out to bids and no bids came in.

Harvey asked if the highway department could remove some trees on the cemetery road that hang out over the road and could fall into the cemetery.
