A great deal of our time has been on snow removal. We had freezing rain on 3/10 and had 2 trucks off the road but had no damage. The Port is out of salt but we have what we need on hand. The total for this winter is up approximately 100 ton.

With the last rain we had only minor water issues on the Hewlett, Lafaver and Given roads with no damage.

We are now working on tree removal starting on Mill Street, Belleville, Fordham and started on Hewlett road. With the early winter we have used most of what we had on hand.

Our maintenance is doing a great job with all equipment on line.

All men have worked well and I thank them.

- I was to get the board prices on trading in the Backhoe; they will allow \$43,000 so I feel the one we have is in great condition only 4 years old so we will keep it for a couple more years.
