- We are still trying to find a Emergency Service Director.
- The governors prison closings are all down state ours are good.
- It was in the paper that a bill was passed to allow illegal immigrants to be issued driver licenses. I will be introducing a resolution in opposition to it.
- He stated to the highway superintendent that Mr. Wesley Dittes has
  concerns about the speed on the Lazy River road bridge. A T9 would have
  to be filled out by the town, send it to the county and then they check it out
  and send the request off to the state for review.
- David Whiteford stated that there are some trees on CR 25 that need to be taken down in County right- a –way near 278 CR 25.
- Morris Jeffries asked about the sluice that is to be replaced on CR 17.
   Larry not sure of all the details yet it will be bored or dug out. Starting sometime in July.

# Highway Superintendent Report: 06/18/2019 \* Larry White

The only work left on our Capital Projects is pouring a top for the catch basin on the Pyrites Russell road and some clean up and grading of shoulders on Mill and Maiden lane. All projects came out as planned and we thank the county crew for an excellent job done. We repaired 2 sections of guide rails on the Pyrites Russell road and Pestle Street and cleared the sand around them for drainage.

We have replaced 1 road crossing and 1 driveway pipe on Pyrites Russell road and removed 1 no longer needed; 1 crossing and 3 driveways on Mill Street and 1 crossing on North Woods road. The old catch basin on the Pyrites Russell road has been removed and we installed a new one.

We have been patching, grading and adding gravel to gravel roads as needed.

On 05/30 we attended our safety and sexual Harassment classes.

We thank Dekalb and Edwards for their assistance with our paving. We will be assisting Edwards tomorrow.

This has been a busy month with good results and I thank the men for a job well done.

Bobby Knox stated that on the end of Burnell road there are pot holes forming on the sides of the pavement. Larry said it will stay that way because they will not keep grading it. Eventually they will do some ditching to help with drainage in that area.
