LEGISLATURE REPORT: Larry Denesha

- Good news we adopted the workers comp fund and it will be 11.5% decrease for Russell.
- Sales Tax- we got a committee to negotiate by the 1st of the year t see how it will be distributed for the next few years.
- There will be early voting this year from October 26 to November 3rd only at the Board of Elections Office in Canton. It was signed into law by NYS and it will be a big expense to the county.
- We passed a resolution opposing a Senate Bill HR1345. This bill takes
 incarcerated peoples benefits away from them and the county must fit the
 bill and as soon as they are out of jail, they get all their benefits given back
 to them. It is a big cost burden for the county. This bill passed
 unanimously because it is a burden on taxpayers.
- The census 2020 will be sending out packets for people to fill out and send back it can also be done online; and if you do not send it back there will be someone coming to your door. The Census DOES NOT call or send emails to people please ignore these if you get one.
- Councilor Whiteford asked if a question about citizenship will be on the census.
- Councilor Burnham stated that the brush across from Hartman's house needs trimming.
- Discussion about spraying guide rails etc. was held. Larry Denesha stated that if spraying within 100 feet of a home, school, business etc. people are supposed to be notified a herbicide is being used.
