GEORGE DODDS:

- I have bought the Wayside Tavern and will be opening soon I am waiting on liquor license to come.
- It will be called Wayside Roadhouse
- I live in Edwards and I managed a bar 40 years ago

JOHN STRANSKY:

- I am from Hermon Rescue and I am checking on where Russell stands with contracting with us.
- Supervisor White met with them and discussed a contract but the board felt they were not informed about it all yet.
- There was more discussion about EVAC and CPR qualifications for drivers.
- The HWY Superintendent offered his men to help when they are available.
- John stated an impact report from all towns involved will be done and Hermon Rescue will show all financial information with the towns.
- It will be a 1-year contract to see how the program goes with a full time EMT on duty.
- Supervisor White stated it will be a \$4,000 increase but it will be beneficial to the town.
- John stated there will be a training day.
- The EMT will be placed by an Agency not Hermon. Hermon will sign a contract with the Agency, and someone will always be there on call.
- Hermon has 7 after hour EMTs

HIGHWAY SUPERINTENDENT REPORT: 09/17/2019 * Larry White

We have completed our reconstruction projects on the Lazy River road. We have increased visibility at the White road intersection from approximately 150 ft to 750 ft.

We have cut shoulders on the Lazy River, North Woods and White roads and added the material to the shoulders as needed for the fill areas.

We have removed trees on the Backus, Forbes and Cassidy roads.

We have replaced pipes on the Pyrites – Russell, Lazy River, Hill, Blanchard and Belleville roads. The pipe on the Belleville road was to increase size to prevent another washout we had earlier.

We have added gravel and graded the gravel roads as needed and patched paved roads.

I will go over the information I have so far on the Spicer road bridge and its red flag inspection.

We have worked with Edwards, Hermon and Dekalb and they helped us truck in fill for our projects.

We will be working on our areas to pave today.

We continue to mow roadsides as time allows.

This has been a busy month with good results, and I thank the men.

HIGHWAY COMMITTEE REPORT: Larry White

The Spicer road bridge has been red flagged, it has 3 pipe crossings. I met with Don Chambers and Andy Willard and the DEC to go over options for the bridge. They suggest putting in a new sleeve. I would like to do a reconstruction of the bridge because it has a poor alignment with Plumb Brook soon.

I got prices on galvanized pipe to sleeve the worst pipe. I would like to ask the board for funding to address this issue.

Supervisor White stated there is money in the fund balance that could be used for the pipe and the core drilling. We can budget \$20,000.00 to cover it.
