LEGISLATURE REPORT: Larry Denesha

- COVID- as of today there were 2 new cases 307 total to date with 7 active cases and 296 released from isolation. As of September 14th there have been 51,549 tested.
- We had a audit report on 8/21 for 2019 books and for the 2nd year in a row they had no findings. We were complimented on our unappropriated fund being at 21 million and in 2016, 2017, 2018 and 2019 the property tax has remained flat.
- Vacancy Revue Process: this is when a position is vacant and the
 department has to come before a board and they review why they feel the
 position needs to be filled and the board determines if it needs to be or

- not. In 2019-2020 we saved 1 million 600 thousand dollars doing it this way.
- We talked about a potential reduction from NYS for Social Services by 20%. The county will have to make up for the shortfall from the fund balance.
- Sales tax: this quarter is down, and Mayor Skelly sent out a letter to town supervisors to support him in getting more sales tax. Supervisor White stated he talked to others and sure it will lower the town taxes but then the county will have to raise taxes. Larry is asking the board not to support Ogdensburg with this change. The board feels it is fine how it is.
- Larry asked if anybody has seen the intersection by Hermon Dekalb school and what they think of it.
