LEGISLATURE REPORT: Larry Denesha

- COVID we had 10 new cases today, 108 are active, 629 total. In October we had 84 cases and in the last 7 days we have had 120 cases. Most are related to gatherings. We encourage people to stay home, wear masks and social distance and wash hands frequently.
- The 2021 budget passed on 11/02 meeting.
- The sales tax negotiations are still going on.
- The 2020 real property tax auction had 110 parcels with 388 bidders. They
 made 2.3 million dollars; 1.4 million last year. 1.2 million was from back
 taxes that were owed.
- There are 2 Bills on the State Senate and Assembly requesting more Legislatures for counties.

- The person that bought the Ferris mower on Auction International came to get it and it would not start or stay running. They said they bought it under the assumption it ran well. It will cost quite a lot to fix it. What does the board want to do? They will buy it for \$200.00. The board said sell it and Tim will call Auction International about it because they will still want their commission.
- Tim stated he has not received a check yet for the truck that we sold on there.
- Tim stated that the sales tax check came in \$30,000.00 more than we budgeted. Larry Denesha stated the sales tax was 4.9% higher in October than it was last year in October.
- Councilor Whiteford stated he had some info on solar lights for the streetlights, there are grants that can cut 56% on the light bills. He will get the info to Supervisor White to check into it.
- Tess explained the paperwork from CivicPlus to do a new website that people can get forms and pay online. Cost would be \$6,000.00 to set it up and \$2,000.00 a year maintenance. The board found it to be to expensive for our small town.
- Superintendent White talked about the CHIPs and said we will be \$30,000 less for 2021. He also stated he will go through his paperwork to see why he is off from the Supervisor accounts.
- Councilor Averill stated she will be her last meeting in December she will do a resignation letter.
- Superintendent white stated Jesse may have the screener up and going in next couple days.
- Sandy stated the FD lacks 4 Christmas decorations yet for the poles and they will all be new.
