- As of today; 41 new cases, 1503 total cases, 16 in the hospital and 27 deaths. On November 23rd we had 794 cases and now we are at 1503 cases in 3 weeks.
- We did a resolution to purchase 2 Reonix rapid testers, it can do 88 tests in a 24 hour period.
- Russell should have gotten Mortgage tax in amount of \$6,301.35
- Our Organizational meeting will be January 4, 2021.
- Councilor Averill asked if there were any reports on how the hospitals are doing. Larry stated they are in good shape.
- Supervisor white stated that some COVID cases were sent to Star lake Hospital.
- Councilor Whiteford stated he is glad the County is getting rapid testers; he got his results after his quarantine was over. He also asked if there were any discussions about salt restrictions at the county. Larry stated not that he is aware of. The Town Pit was discussed and how it is dealt with pertaining to salt.
- Larry White gave Larry D. a map of ash trees in Russell for the ash borer study.

BOND RESOLUTION OF THE TOWN OF RUSSELL ADOPTED DECEMBER 15, 2020, AUTHORIZING THE PURCHASE OF A 2020 PETERBILT PLOW TRUCK, MODEL #567, WITH TENCO PLOW, MODEL #H345-FW, AND AUTHORIZING THE ISSUANCE OF BOND ANTICIPATION NOTES OF THE TOWN IN THE PRINCIPAL SUM OF \$226,210.00 AND/OR SECURING A COMMUNITY FACILITY PROGRAM LOAN/GRANT THROUGH USDA RURAL DEVELOPMENT FOR THE ENTIRE SUM OR A PORTION THEREOF.

RESOLVED, this 15th day of December, 2020, by the Town of Russell, County of St.

Lawrence and State of New York, at a regular meeting at which Supervisor Timothy White and

Councilors Tommorah Averill, Charles Kerr and Edward D. Whiteford were

present, as follows:

Section I. The expenditure of \$226,210.00 which the Town of Russell requires for the

purchase of a 2020 Peterbilt Plow Truck, Model #567, with Tenco Plow, Model #H345-FW, is

hereby authorized. The total estimated cost of the purchase is approximately \$226,210.00.

Section 2. The plan for financing the said capital improvements consists of the issuance of bond anticipation notes of the Town in the principal sum of \$226,210.00 and/or issuance of a Community Facility Program loan/grant from USDA Rural Development for the entire sum or a portion thereof Section 3. Bond anticipation notes in the principal amount of \$226,210.00 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law.

Section 4. The period of probable usefulness of the aforesaid purpose for which said bonds are to be issued pursuant to Section 11.28 of the Local Finance Law is hereby determined to be fifteen (15) years.

Section 5. The full faith and credit of said Town of Russell are pledged to the payment of the principal of said bond and interest thereon when due.

Section 6. It is hereby determined that the proposed maturity of the obligation authorized

hereby will not be in excess of five years.

Section 7. The Secretary is hereby authorized and directed to sell such bond at private sale in accordance with the provisions of Section 63.00 of the Local Finance Law.

Section 8. The bond shall be in substantially the form set forth in the attached Schedule "A" which is annexed hereto and made a part hereof as if incorporated herein.

and seconded by Councilor Charlie Kerr, and duly put to a vote on roll call, which resulted as follows:
