- I went down to the town barn last week and the power was turned off to the used oil burner. I asked the men to turn it on and get it running for me to see how it worked. It had to be reset to run once the power had been turned off. They got it working and I asked them to leave it on so it can do its job. I was under the impression that is what we purchased it for. A couple days later I stopped, and the power had been shut back off. That Saturday the temp dropped to -8% if something went wrong with the boiler, we would have no heat. I would like to see the power be left on and the thermostat to be set at least 55. What does the board think?
- Superintendent White stated we have used oil on hand but by using the wood boiler we have saved over \$9000.00 this year. When the weather gets 0 or lower, we use the oil burner. I feel 40-45 degrees in that bay is warm enough. We build the wood burner at least 3 times a day, we will use the oil burner when it is needed.
- Supervisor White stated he would like to see it left on just to see how much oil it uses.

- WE got \$275,000 in interest in 2020.
- We passed a resolution to keep sales tax distribution the same as we have been doing it.
- We took in 3+ million more in sales tax than was budgeted.
- We passed a resolution to purchase 34 body cameras for the sheriff's department. They will use \$50,000 from there budget and we will give \$10,000.
- DANC is doing a survey to see where Broadband internet is needed. There is money available to help with this.
- Supervisor White asked if people being home and internet shopping and spending local is why sales tax is up. Larry said he is sure it is.

The new truck is in and online all trucks are working well with only minor issues.

We have made repairs to the clean- out doors on the wood furnace that had rusted out. The furnace was installed 11/01.08 and will need replacement in the near future.

We are now working on a stationary screen for the pit to do away with individual screens for each truck.

This has been a busy and productive month and I thank the men.

Councilor Whiteford stated the new truck is nice.

Larry stated they changed the flares on the new truck because the ones on it were small.

Larry handed in a handwritten shared service agreement between the Town of Russell, Hermon, and Edwards stating that in the event COVID strikes one of our departments the others will send their trucks in to clear their roads. Roads will be rated primary and secondary to determine the amount of service required. Each Superintendent will supply maps showing their routes. ### **RESOLUTION #26**

ADOPTING THE PROVISIONS OF EXECUTIVE ORDER NO. 202.83 SUSPENDING THE REQUIREMENTS OF RENEWAL APPLICATIONS AS A CONDITION TO GRANTING EXEMPTIONS UNDER SECTIONS 459-C AND 467 OF THE NEW YORK STATE REAL PROPERTY TAX LAW.

Councilor Burnham offered the following Resolution, which was seconded by Councilor Whiteford .

**WHEREAS**, the Governor of the State of New York by Executive Order No. 202 dated March 7, 2020, declared a state disaster emergency for the entire State of New York; and

WHEREAS, pursuant to Section 29-a of Article 2-B of the Executive Law, Governor Andrew Cuomo additionally issued Executive Order 202.83 dated December 18, 2020, which authorized, by local option, the governing body to adopt the provisions of that Executive Order 202.83, which temporarily suspends or modifies Subdivisions 7, 7-a and 8 of Section 459-c of the Real Property Tax Law and Subdivisions 5, 5-a, 5-b, 5-c and 6 of Section 467 of the Real Property Tax Law, thereby allowing local assessors to more easily grant exemptions to qualified property owners;

# NOW, THEREFORE, BE IT

**RESOLVED,** that pursuant to said Executive Order 202.83, the Town Board of the Town of Russell hereby temporarily suspends the notice requirement of Subdivisions 7, 7-a and 8 of Section 459-c of the Real Property Tax Law and Subdivisions 5, 5-a, 5-b, 5-c and 6 of Section 467 of the Real Property Tax Law; and it is further,

**RESOLVED**, that the Board of Assessors are hereby directed to grant exemptions pursuant to such Sections on the 2021/2022 assessment roll to all qualified property owners who received that exemption on the 2020/2021 assessment roll, thereby dispensing with the need for the submission by said owner of a renewal application and further dispensing with the requirement for the Board of Assessors to mail renewal applications to such persons; and it is further.

**RESOLVED,** that the Town Clerk is hereby directed to forward a copy of this Resolution to the Board of Assessors and the Office of the Town Assessor; and it is further,

**RESOLVED**, that notwithstanding the above suspension, the Town's Assessor may nevertheless require said property owner to file a renewal application when he or she has reason to believe that an owner who qualified for the exemption on the 2020 assessment roll may have since changed his or her primary residence, added another owner to the deed, transferred the property to a new owner, or died; and it is further,

**RESOLVED** that the suspension of the above Sections of Real Property Tax Law and filing requirements shall end prior to the next 2021/2022 tax year, unless otherwise extended by applicable State and Local Law.
