PUBLIC DISCUSSION:

Patrick Kelly – St. Lawrence County Industrial Development Corporation:

- I am the CEO of the IDA.
- We follow the NYS Municipal Law for tax incentives.
- We provide services for marketing incentives for businesses. We try to draw new businesses to St. Lawrence County.
- The Pilots are taxes in Lieu of taxes. It allows break on taxes for a certain number of years.
- We want to secure the pilots to help Towns and school districts.
- The Real Property Tax Law 487 provides all solar farms a tax incentive. Developers are searching out places for farms to take advantage of the state incentives.
- We have approved 16 solar farms with the IDA Pilot we lease from the developer and sell back to them. We try to bring consistency with all developers. We build in protections for the communities.
- Towns receive Pilot payments from the county.
- We are trying to figure a fair pilot value for all solar farms here in St. Lawrence County. We try and do a 2% increase each year. We try and be fair we are not the highest or the lowest.
- The town will have to agree to the Pilot.
- A downside for us is they are not a big job provider. But the landowners receive revenue for the farms.

- We talk with the Providers to negotiate cost per megawatt and come back to the Towns.
- We will always come back to the town with updates as the projects advance.
- We only do what the Town Board approves.
- Supervisor White asked if the old J&L mines area was for a solar farm? Patrick stated it is going to be a utility scale.
- Is the solar farm in Lisbon about the size of the one projected for here? Patrick stated yes.
- Larry Denesha stated he thought there were more questions asked and not enough answers that is why he suggested the town contacting the IDA.
- Thank you, Patrick, for the information.

JODY WENZEL: Director of the St. Lawrence County Risk Management.

- I work with the workman's comp if you have any questions, please contact me I will help anyway I can when you are filing a claim.
- We administer safety audits for towns, I will walk through the facilities and I will look for things that are safety issues. I will send a report on each building to the town. The town will review them; date them when issue is completed and send back to us and we file them. The state likes to see that they are done. We are 3 weeks out in scheduling so we will get a hold of you as soon as we can.
- I will look to see if a workplace violence policy is in place.
- We have all kinds of training for employees; you can reach out if there is a particular training you would like done.
- I am in the process of being an OSHA trainer.
- Thank you, Jody for the information.

LEGISLATURE REPORT: Larry Denesha

- As of today, we had 11 new COVID cases. 3 are in the hospital.
- On 5/4/21 we passed a resolution to support the NYS law to allow 12- & 13-year-old to hunt big game with a adult. We will hold a Public hearing on June 5th for people to voice their opinion on the matter.
- We passed a resolution May 15th for National Police Week as a good gesture recognizing our St. Lawrence Law Enforcement.
- CHIP's will be about a 40% increase for Town & Villages above the 15% they get.
- 2 Highway buildings will be getting bids that will be opened on May 24th. Potsdam one is on hold.
- The CR 27 bridge will be closed June1st to November 1st, it will be widened 4 feet and be paid for with Bridge NY funding.
- The Lazy river bridge will be in 2022 scheduling County will do 5% of the cost.
- The Dutton road bridge will be done in 2022 with county funding. A precast will be used on this bridge.
- The Multi Trail opened Saturday a lot of people were out on them. There
 were concerns about UTV not being able to be registered so St. Lawrence
 County looked at Lewis Counties law and it was done as AV-UTV under
 Off-Highway Vehicles; we are doing something similar. You can go online
 and get an application and apply to the County Clerk office for registering
 the UTV, it will cost \$65.00 and if you belong to an ATV club cost will be
 \$45.00. Only to ride on the Multi Trail System.
