PUBLIC DISCUSSION:

LEGISLATURE REPORT: Larry Denesha

- COVID: 1 new case as of today. State mandated restrictions have been lifted due to NYS hitting 70% vaccinated all but schools, nursing homes, hospitals, prisons etc. St. Lawrence County vaccinations are only at 61% a week ago but the Potsdam Maxy Hall site is shut down now.
- We passed a resolution making June the Dairy month.
- We released funds for the 2021 Bass Masters tournament in Waddington.
- We passed a resolution to do Environmental studies for the (Loop) Bice store in DeGrasse, the gas station near AMVETS on Route 11 and one in Fowler. State DEC will do clean up and we foreclose on them and put them on the auction to be sold and split the money with DEC.
- The Broadband survey is closed we got 2100 responses now we will do a analysis on the results.
- The 2020 Tax Collection rate for St. Lawrence County was at 90.65% and in 2019 it was at 90.83%.
- We passed a resolution for Septic Replacement Assistance with the North Country Housing Council with funds of \$384,000.00. If someone wants to get on the list for assistance call 315-379-2292 or 315-386-8576.
- We passed a resolution to sign a contract with Northern Tier Contractors from Lisbon for the 3 salt/storage buildings that will be done by late fall. ENI got the plumbing bid, and TEL Inc. got the electric bid. The cost will be \$4million 577 thousand 950 hundred dollars.
- We took a voice vote in favor of doing a ATV bridge for the Lafaver road bridge but it is on hold because the NYPA want to put a construction bridge in to move the powerline material.

• Sandy asked when the CR 27 bridge will start now it was supposed to start June 1st. Larry is not sure.

- Larry White asked Larry Denesha about the Summer Youth Program? Larry White stated he took the contract to the town insurance agent to look over.
- Larry Denesha stated he voted against it due to concerns of insurance. He said it has not been changed yet but it may. Some feel there is a lack of supervision with the youth and that is a concern.
- Larry White stated his youth are always supervised; he feels it is a good program. Larry Denesha stated some towns have opted out of the program, but they are insured with NYMER. He suggested calling Barb Lashway from the Youth Bureau director.
- The Town Board feels if the Youth program will waive the one paragraph and our insurance covers them if there is an issue then go ahead and do the program. Supervisor White stated if the board needed to discuss it further a special meeting can be called.

JACK WHITE:

- Jack stated on January 19th I asked when you were picking up the town property after I was let go as DEO. Tim said the 20th of January. Tim stated you wanted proof of insurance and a letter from town stating your removal from DEO before we could go on your property. Jack stated he received both. I recently got a letter from the Town lawyer asking me to return the Chip Reader to the town. I want all my storage rent paid up before you can get the property. Councilor Burnham asked Jack why you cannot just return town property as you are no longer DEO. Jack stated I want my rent first. Jack stated you can have the chip reader if I can keep the kennel. Tim stated you are not under contract with the town. Tim stated you can keep the kennel just return the chip reader.
- Jack brought the chip reader in and showed the board that it is in good working condition. It has an automatic shut off mode.

We have completed shoulders, ditching and 2 small blast areas on the Backus road.

We have added patch on Kimble Hill to the guide rails in prep for paving to reduce wash outs.

We have replaced a section of shoulder on the Hill road with clay and stone to repair wash outs.

We have blasted 2 small sections on the Mackin road seasonal section and repaired wash outs.

We have cut brush on the Blanchard Hill road and are now cutting on seasonal section of Blackmer road in prep for road work.

We have completed mowing roadsides for the first time.

We have cut shoulders on the Curtis, Silver Hill Center and South sections and the Spicer roads.

There is a change in CHIP's Funds that I have adjusted to present.

I thank the men for a productive month.

We have been reinstated \$50,000.00 from the state; \$38,000.00 was in CHIP's. I have amended my projects reflecting the monetary changes if the board will sign and accept them. The board members and supervisor signed the amended Agreement To Spend Town Highway Funds with the changes to expend the sum of \$233,121.00 on 77 miles of Town Highways.
