SUPERVISORS REPORT: 08/17/2021 - Tim White

- 1. Financial Report
- Details of all income and expense transactions have been filed with the Town Clerk.
- Account balances as of August 17, 2021, for the general fund, highway fund, capital improvement fund, and streetlight fund have been filed with the Town Clerk.
- Andy Wood and I met and came up with a list of supplies needed to start
 the bathroom and grill area work. We have lined up some volunteers to
 help with the work also. I picked up the fence and most of the post also,
 and we are hoping to start this weekend.
- Larry asked at last meeting about the road that goes to the river in Downerville. I spoke to the DEC, and the officer told me that that road is ATV legal to the parking area. If the ATV's stay on the road or in the parking area they are fine. They cannot drive down to or in the river. He also stated there were no ATV's beyond this point, he said there were signs in the parking area and he check to see if they are still there.
- I have received the verification letter from the state that we will receive \$182,741.00 from the coronavirus local fiscal recovery fund. Half the money will come this year and the rest next summer.

LEGISLATURE REPORT: Larry Denesha

- Speaking of the Coronavirus recovery funds; It is supposed to be used for anything that was adversely affected by COVID. My advice is whatever you spend it on keep receipts and an account of where it was spent. Just in case the town gets an audit on it.
- COVID: Public Health will do appointments for on-site vaccinations. As of Friday -Monday there were 120 new cases mostly unvaccinated people. Public Health recommends people wear masks in public areas.
- The Sheriff is holding new pistol safety classes on August 31st 5-9 Pm and September 1st 5-9 PM you need to register for the class and the cost will be a \$30.00 fee.
- We passed a resolution to get federal aide to help with bridges.
- The 2020 final audit report showed sales tax at 65.4 million. It has been going up since 2017.
- Larry White asked why does the county cut highway but never anything at Social Services. That is state mandated, and it prevents any cuts. The state sets the number of cases Social Services can have also. Larry White stated our government overall likes to do handouts.

Highway Superintendent Report: 08/17/2021 * Larry White

We have completed our paving with 9.25 miles covered; 3.35 top and 5.9 shim.

We have helped Dekalb and Edwards with their paving and we want to thank them as well as Canton, Pierrepont, and Hermon for their help with us. We are now working on shoulders.

We have cleaned around guide rails as time allows.

We have installed driveways on the Cassidy, Colton and Backus roads and 1 crossing pipe.

We have taken a truck to Stadium International for repairs.

This has been a productive and busy month and I thank the men.

Councilor Beachard stated he was asked why the town highway is doing driveways. Larry stated we work within the 25 feet from center of road to ditch; so, we install pipes that the landowner purchases for new driveways. If the pipe already exists, then we replace it because after they are in, they become the towns because they are in the 25-foot distance.

HIGHWAY COMMITTEE REPORT: Larry White

- I figured after all the paving projects were done, I have \$15,392.59 left over.
- There was some discussion about the amount left over but it came out that the \$15,392.59 was correct.
- Larry would like to do some shimming on the West Road and Backus Road with it.
- The board wants to hold off a month to see if the county can help with the paving before the highway men lay it down.
