

Thereafter, and notwithstanding the adoption or euthanasia of said animal, the owner of record shall be deemed to have abandoned said animal and shall be liable to the Town for a civil penalty of a minimum of Two Hundred Fifty Dollars (\$250.00) and a maximum of Five Hundred Dollars (\$500.00) for each such violation.


