Financial Report:

- -Details of all income and expense transactions have been filed with the town clerk.
- -Account balances as of March 17, 2020 for the general fund, highway fund, capital improvement fund, and street light fund have been filed with the town clerk.
- I am looking at a grant for a new plow truck. I will go over the details with the Board if this is something they want to look at doing.
  - It will be a USDA grant to finance with a 2.9% interest rate with no early pay off penalties. I feel if we put \$35,000 from the fund balance each year will cover the payment. I will have the rest of the paperwork for the next meeting. The board agrees a new truck is needed. Highway Superintendent White stated he is against spending that amount of money on a new truck.
  - In light of the Corona virus I would like to cancel all activities in the community room. I would also like to get some input from the board as to some other precautions we can take to keep the community safe.
  - We will close all the Town offices to the public as of 3/18 until further notice. She will be open 8:00 Am to noon for calls, mail etc. The Town Clerk/Tax collector has a drop mail slot on her door for tax payments to be dropped off into.
  - The Court has been closed and adjourned till further notice
  - The Russell Public Library is closed until further notice
  - The community room is closed till further notice
  - We will close the highway down
  - Everyone on highway will still get paid there 40 hour week
  - I will post this information on the radio and send an email to North Country now.

We have cut trees on the Lafaver and Boyd Pond roads.

We have stripped the ledges on the Boyd Pond road project and have them drilled. We are scheduled to blast on Wednesday. This is called off now.

We have moved the Athney loader in for some repairs and adjustments.

We have received our last salt order for a total of 334 tons. Down approximately 30 ton from last winter.

We have been patching roads as time allows and started sweeping some of the roads with heavy buildup.

I thank the men for a job well done throughout the winter.

Councilor Whiteford asked if highway department puts out Ash Borer traps. Larry stated the DEC does that. We only report the trees we cut down that are ash trees.
