#### **PUBLIC DISCUSSION:**

#### Colleen Friot & June Jenne: Co-Historians:

- We received a prize possession From England from Mr. Atwater. It is a 1815 deed document for ½ acre land which we think is the Russell cemetery. It is signed by Russell & Rueben Atwater. We took it to the Canton Historical Society they said they would put it in a preservation box but when we went back there was a new person and she said we had to deed it to them, and we will not do that. Commercial Press is doing a copy for us to display on wall of museum.
- We received 3 more documents from June Jenne from 1886,1871 and 1872. One is a Chattel mortgage document with Garrett Smith on it. He secured mortgages from people that went bankrupt.
- I was taught on how to preserve documents and we were asking the board if a fireproof safe can be bought to store them in. The board has no issue with that.
- Colleen set the document out so the board and public could look at it.
- Councilman Burnham stated that the Co-Historians are doing a great job.
- We also received all the books from the Ladies Society from the Methodist Church.
- We had 2 classes from school come and do research on Tiffany Window and then Seymour Knox.
- We are looking into a Historical Blue & Yellow historical marker. We thought the Turnpike or Arsenal would be good but we didn't have enough

on the Turnpike and the marker has to be seen from the road so the Arsenal will not work. So, we were thinking the Town hall. The board would need to find a location to put it and written permission from the board. The board will work with them on this.

# **LEGISLATURE REPORT: Larry Denesha**

- COVID: Month of July there were 719 new cases, 200 deaths to date. Things are getting better.
- We passed a resolution to have new Fobs put in at the highway outposts
- We passed a resolution to put a camera security system in at the highway outposts, they are motion activated.
- There are 113 parcels for tax sale auction. Auctions International will be doing online tax sale again starting September 10<sup>th</sup> to the 24<sup>th</sup>.
- Workers Comp for Russell went down this year because of no work injuries.
- The 2021 audit is out it is the 3<sup>rd</sup> year with no issues.
- Sales tax revenue was down 30% for June & July from last year.
- It is budget time we hope to keep the same or even lower it if we can. Our good fund balance helps.
- We passed a resolution to create a Residential Property Account. We will
  put \$200,000 to start and add \$100,000 a year after that from sales of
  property to help fix up deteriorating properties and get them on the auction
  site.

- Councilor Whiteford asked if Dutton Road bridge was open? Yes it has been for over a month.
- Supervisor stated the bridge in Pierrepont is behind 2 weeks.

# Highway Superintendent Report: 08/16/2022: Richard Meilleur

All back stops have been removed from the ball fields.

We have completed our paving projects and backed up all the shoulders. We paved .4 miles on Boyd Pond Road, 1 mile of shim & Top on the Pyrites-Russell Road, 1.3 miles of shim & Top on the West Road, and 1.2 miles of Top on the Cassidy Road. I would like to thank the Towns of Hermon, Fowler, Edwards and Dekalb for the use of their trucks on our paving projects.

We have been screening sand for winter roads and cutting brush on the Hewlett and Donnerville roads.

We have installed 3 12" driveway culverts on the Hill Road and have done ditch cleaning in various locations also the roadside mowing is about 75% complete.

Tyler Bristol has 5 years of service as of 8/1/22 and is due 1 week more vacation time.

Tim and I met with NYPA and Michaels and submitted a bill for \$96,000.00 in damages from the power line project to North Woods Road and Lazy River Road.

I would like to thank the men for another safe and productive month.

- Councilor Beachard stated Richard hired Shane Mackin 8/1/22
- The new Patch truck is going into production in September. The board still feels this truck is needed.
