We have been busy cutting brush and dead trees on the Cassidy, Pestle Street and Hill roads.

We have put down 304 inches of crushed gravel on 9 tenths of a mile of the North Woods Road per agreement with NYPA. Also, we paved 4 tenths of a mile on Lazy River Road which started oat the Hermon Town Line and went to the construction entrance for the power line. We used left over CHIPS funds that will get reimbursed when the check comes from NYPA.

We have cut shoulders on the Marshville Road.

We picked up the new insert sander that we ordered.

All the trucks have been serviced and are ready for winter. We have harnessed up one truck and we have replaced sprockets and chains on all sanders that needed to be replaced. We will be harnessing up the rest of the trucks this month.

I placed an order for 75 tons of salt; that should get us to the 1st of the year with what we had left over from last spring.

We have gone to five (5) 8 hour days Monday thru Friday 7:00 am to 3:30 pm.

I would also like to thank the men for another safe and productive month.

Richard asked the board to do a resolution authorizing using ARPA FUNDS for sander chains, blades, and snow plow parts.

RESOLUTION # 70 **ARPA FUNDS**

A motion was made by Councilor Kerr and seconded by Councilor Whiteford: **THEREFORE:** the Town Board authorized the purchasing of sander chains, blades and snowplow parts with ARPA FUNDS as per ARPA guidelines for towns filed under revenue loss (6.1) which entails anything that is a normal budgeted item, would be allowable.
