LEGISLATURE REPORT: Larry Denesha

- Resolution passed modified 2023 Budget for Treasurers Office for Sales Tax was \$3,025,000.00 more.
- Introduced a resolution opposing "Safe Harmless Claus", schools will get no less money than previous year. Clifton-Fine, for example, would have a 24% cut in State Aid, almost \$1,000,000.00.
- Work on the Emergency Services Building has begun.
- Proposal presented and passed Monday evening want to establish Satellite DSS Office. Ogdensburg, Massena and Star Lake already have. It is better to serve the public as some people have a hard time getting to the Canton office.
- There will be a meeting 2/21/24 for school resource officers. Larry is representing Edwards-Knox to keep what we have.
- Asked Dereck, the Town Board and community for their support on the Resolution that was presented to them in the Urging of Governor Hochul to Double the amount of Funding for Critically Needed Aging Services for the 2024-2025 NYS Budget so that Older Adults May Age Safely in Place.
- Highway Resolution Modified 2024 budget 44.34 more miles of paving to be done. Because there is a healthy fund balance 19%, they want to give back to public in form of more paving, 79.23 miles this year.

HIGHWAY SUPEINTENDENT REPORT:

We have spent most of our time maintaining winter roads. We have also cut brush and about 20 large trees that were dead or dying and in danger of ending up in the road.

We have been using the boom mower on the Hill Road. All the roadsides were also cut back on the Hill Road.

Our new plow truck was sent to Syracuse for repair of a bad set of front springs. It was only gone 4 days and they added heavier set of front springs. There was no charge as it was under warranty.

I am hoping to start the Dana Hill Road culvert replacement within the next 2-3 weeks depending on the weather. We need to clean about 600 feet of ditch before we can put the culvert in due to 30 inches of water where we need to install the new culvert.
