- On the 3rd of June adopting a Local Law 2024 for St Lawrence County regarding a wireless communications surcharge for emergency services. An additional \$0.30 wireless surcharge will be in place for emergency services/911 calls. 77% of calls that come into emergency services are wireless. There already is a landline surcharge in place.
- They have passed a resolution making June Dairy month in St Lawrence County.
 In 2023 there were 176 dairy farms operating in St Lawrence County.
- Some areas of County Route 17 have been paved.
- There was a conference call with Chief's of Staff from Senator's Blankenbush, Walczyk, and Stefanik offices regarding Russell Volunteer Fire Department pumper truck and roof. Recommended Luke Manning to see about USDA Grants.
