The meeting was called to order at 6:00 pm by Supervisor Matthews

#### **PUBLIC DISCUSSION:**

- Tom Robinson came to discuss the 3 dogs on Pestle Street Road that were chasing people and had bit people while walking for the past 4-5 months. The property where the dogs are located is also trashed, he would like Code Enforcer to go check it out. Kay Amo stated that nobody wants to walk the road anymore due to fear of the dogs. She also wanted to bring to attention that there is a 1–3-mile walk planned this weekend that brings people right by the house.
- John Whitmarsh stated that there were dogs running up by his house at 2:00-3:00 in the morning.
- There are dogs that have been repeatedly loose and running around town that belong to the people that live next to the Town Barn.
- Dan Moyer, Dog Control, was there to answer questions and concerns. He
  explained the importance of filing a report when bit by a dog. If a report isn't
  filed, he is not notified to respond. He also stated to call him if dogs are out
  running loose or if someone is bitten. He will be leaving the meeting and going
  down Pestle Street Road to see if the dogs are out or if he can speak to the
  owner of the dogs. If he doesn't see them today, he will try again the following
  day.

- Chelsea Reynolds spoke of concerns about ATV's and UTV's speeding by her
  house on the dead end Mackin Road all hours of the day & night. She has
  children that could be harmed and large trucks that they could possibly hit and
  harm themselves. The Board informed her that there is nothing the town can do,
  it would be NYS DOT. The Board suggested contacting law enforcement and/or
  put-up cameras with a sign letting them know they are on being recorded.
- There is also a culvert by Chelsea's house that may need to be fixed. Richard will check to see if it is plugged and needs to be cleaned out.

# **LEGISLATURE REPORT**: Larry Denesha

- Two events coming up. The Senior Picnic August 15<sup>th</sup> at the Gouverneur Community Center. There will be bingo, lunch served and musical entertainment and the Senior Rama July 22 at the Mohawk Bingo Palace in Hogansburg.
- They have passed a resolution for the Sheriff's Office to purchase an Inception
  Whole Body Contraband Detection Scanner for St Lawrence County Correction
  Facility. It detects metallic and non-metallic items (drugs, weapons, cell phones,
  swallowed balloons, etc.) for people being brought in.
- Passed a resolution modifying the 2024 budget for the Sheriff's Office
  prescription for costs at the St Lawrence County Correction Facility. They have
  added an additional \$200,000.00 to get through to the end of the year. Once a
  person is incarcerated, if they are on Medicaid, Medicaid no longer covers the
  individual and the County must pick up the cost.
- The 2025 budget team has begun the Tuesday July 9<sup>th</sup> and continues until Thursday August 22<sup>nd</sup>. The Tentative 2025 budget will be presented to the finance committee Monday September 30<sup>th</sup>. Budget reviews will be held October 7<sup>th</sup>, 21<sup>st</sup>, and 28<sup>th</sup>. Public Hearing on November 4<sup>th</sup>.
- The Tooley Pond Road is still closed due to flood damage.

# **Highway Report**

We had quite a bit of damage from the recent storms. I have been in contact with Don Chambers, and we are hoping to get some help from the state with the cost of storm damage. We have got all our roads back open as of Monday afternoon. We worked overtime on Friday to get all the roads passible.

The bridge on Silver Hill Road sustained some damage, mostly gravel washed out around the wing wall. We have replaced the gravel and checked the rest of the structure, and it looks okay. McCarthy Road bridge also sustained some damage to the approach and is still open. The County is assessing the damage as it is their bridge.

The bridge to the pit had some damage and is closed until we can get it fixed. We are working on it today and hope to have concrete poured by next week. We have also been cutting shoulders and cutting brush. We are working with other towns on shared service paving projects.

I would like to thank the men for another safe and productive month.
